Sélim El Sayegh is a Professor of Law and International Relations at the Paris-XI University since 1993. He is currently the Director of the Master's Program in Diplomacy & Strategic Negotiations at Paris XI University & La Sagesse University in Beirut, and the President of CADMOS (Center for the Analysis of Disputes and their Modes of Settlement) since 1994 and 2001 respectively. He has been the Co-Founder and Vice-President of the American Graduate School of Diplomacy since 1995 in Paris. He has been a Visiting Professor in more than twenty universities around the world. His main area of specialization is conflict resolution, negotiation, diplomacy & development studies.

El Sayegh was the Minister of Social Affairs from 2009 till 2011 serving under the Hariri Government. During his leading position in the government, El Sayegh developed policies and strategies that excelled the social sector in Lebanon. He led the development of the Social Pact & the National Strategy for Social Development in Lebanon; oversaw the implementation of the Good Governance Standards to NGO's; led the creation of the 1<sup>st</sup> Middle Eastern Master's Degree of NGO Management; established the National Documentation Center for Childhood; and developed the elderly care taking centers standards. El Sayegh contributed to the development of many innovative national programs aiming at enhancing the living conditions of the Living Conditions of the Poor.

EL Sayegh is an internationally and regionally recognized expert in his field. He currently serves as a Senior Adviser for the UNESCO Program on Intercultural Dialogue. He has been on the board of World Bank for Social Politics in the MENA region since 2012. He is a distinguished lecturer and frequently quoted in the national and regional media. He has also obtained a number of international academic professional awards and appointments. He is the author of numerous publications in French, English and Arabic.

El Sayegh received his PhD in International Law & National accreditation to supervise PhD Thesis from Paris University in 1992. He has DEA (M.Phil) in History from the Sorbonne University (Paris 1), and an M.A in Diplomacy and International Relations from Paris-XI University in 1990 and 1989 respectively. He has Bachelor degrees in Political Science, Law & Business Management from different universities in Lebanon in 1986, 1985 & 1983 respectively."



Mr. Raed H. Charafeddine

**Raed H. Charafeddine** has served as the first vice-governor of the Banque du Liban, Lebanon's central bank, since April 2009. He is the alternate governor for Lebanon at the International Monetary Fund (IMF) and the Arab Monetary Fund (AMF) and the alternate chairman of the Capital Markets Authority in Lebanon. In 2013, he was elected executive director for the Levant region at the AMF's board of executive directors.

Mr. Charafeddine represents Lebanon at the IFC committee on central bank statistics at the Bank for International Settlements (BIS) and is the national coordinator for Lebanon's participation in the IMF's General Data Dissemination System (GDDS). Mr. Charafeddine is also the co-chairman of the capacity building task force of the COMCEC Capital Market Regulators Forum.

At BDL, he chairs the information security management and Islamic banking regulatory committees and is a member of the bank's central council (governing board), the open market, and the investment committees. He also oversees several areas at the bank, including:

Strategy and corporate governance

Statistics and economic research

Information technology

BDL branch network

Cash operations

Mr. Charafeddine is the chairman of the Advisory Council for the Islamic Finance Qualification (IFQ), an internationally-renowned certificate and a jury panelist in the "Lebanese Excellence Award", Lebanon's national quality award.

Prior to assuming his current responsibility, Mr. Charafeddine had 20 years of banking experience. He held senior positions including deputy general manager, regional manager, and branch manager in leading commercial banks such as Fransabank and Byblos Bank in Lebanon as well as Mashreqbank in Dubai, U.A.E.

As a lifelong activist, Mr. Charafeddine also served as a board member in several NGOs dealing with social justice as well as organizational, human, and local community development.

In the academic realm, Mr. Charafeddine lectured at Harvard, Yale and INSEAD on the current challenges of the Arab transition, particularly on the economic, financial, social and cultural aspects. In Lebanon, he was a visiting lecturer at select universities where he facilitated graduate and undergraduate courses in strategic management, leadership, and leading change. He also trained senior staff in many corporations, educational institutions, governmental and non-governmental organizations and made numerous contributions to national and international forums on the issues of governance, quality management systems, conflict management, peace building, interfaith dialogue, and personal and group development.
